1. This registration is subject to rule 3(4) and (5)
2. It is mandatory to the Governing Council to follow the rules under 4(4)
3. The Governing Council should provide the school building, premises, study materials, furniture's categories of employees, financial assistance.
4. The provision of Govt. order ED: 10 D:98: dated 17.03.2000 is considered before issuing permission to start Kannada Medium School.
5. The school should not commence additional division without prior permission of the Govt.
6. The school should run within the prescribed location and in Kannada medium of instruction and should not change the same for any reasons.
7. The school should run by the management to which the permission certificate is issued and it should not be change or transfer for any reason without prior permission of the Govt.
8. As per the Govt. Order no. ED: 44: VGC: 2002 Bangalore date 11.06.2002 those institution registered on compulsory Kannada language policy from class I to V, If violated the Kannada language policy and it came in to the notice of the 'Kannada Abhivrudhi Pradhikara' will cancel the registration of the institution.

9. Every year the institution shall conduct the medical tech of each student
10. The institution shall abide with the rules and conditions of 'Karnataka Comprehensive Education Act 1983 (Karnataka Act of 1995)' and directions of concerned authorities.
11. The institution is considered as unaided institution under the provisions of educational institutions no. ED: 175: PMC: 95 date 07.09.1996 and Govt. order no ED 175: PMC:95 date 29.12.1998.
12. The institutions shall follow the rules and regulations of "Karnataka Private Educational Institutions (Discipline and Regulations) rule 1978".
13. Within 2 month of commence of institution shall apply to the Block Educational Officer and Dist. Asst. Director for permission. Afterwards every 3years shall apply for renewal of permission.
14. Every permitted institution shall maintain the required ratio between student and teachers.
15. Trained and qualified teachers should be appointed as per the norms prescribed by the department and every institution shall maintain service book for every teaching staff.
16. Every institution registered under Article 6 of Karnataka Education Act Under rule 36 to 39 will come within the purview of recognition and provisional recognition.
17. The institution shall open a security deposit in a Nationalized Bank in the join name of Block Education Officer and Secretary of the Managing Committee.
18. As per the provisions of Karnataka Education Act 1983 the Institution Shall provide with study materials, furnitures, Library Books, Play Ground, School Building etc within one year. Failing in which the registration will stand to be cancelled.
19. The name board of the school shall contain Kannada Medium School from class 1 - 5 as per the registration obtained in the office Block Education Officer.
20. About the commencement of the school and the admission of the student should be intimated to the Block Education Officer failing which the permission will stand cancelled.
