



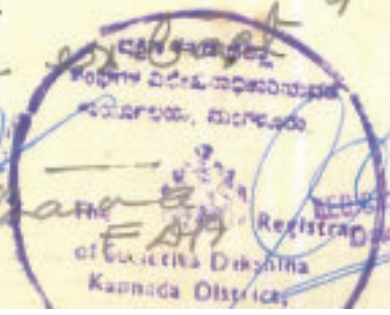

MEMORANDUM OF ASSOCIATION

1. The name of the Society shall be "ACADEMY OF LIBERAL EDUCATION".
2. The Registered Office of the Society, P.O. Sullia, South Kanara, Mysore State.
3. The Objects of the Society are:
  - (a) To impart General/Technical Education to boys and Girls.
  - (b) To establish/run/aid educational institutions both General and Technical and Tutorial.
  - (c) To establish/run/aid institutions for Commercial subjects such as Commerce, Accountancy, Book.keeping and Auditing, Typewriting and Shorthand, etc.
  - (d) To establish residential hostels for boys and girls separately.
  - (e) To establish educational institutions and Colleges



as and when the Society may deem fit and feasible.

- (f) To promote and develop interest in Arts, Science, Literature, Domestic Science, Humanities, Vocational and Basic Education.
  - (g) To found and maintain Libraries and Reading Rooms and Museums.
  - h) To arrange lectures and discourses by competent persons on moral instructions on non-denominational lines.
  - (i) To publish Educational Journals and Periodicals.
  - (j) To purchase, construct, take on lease, assignment, mortgage or otherwise, tenements, buildings, easement, rights and advantages of any kind whatsoever, occupy, maintain and use for the purposes of the Society, and resell, let, lease or otherwise deal with the same and borrow funds on the pledge of liquid assets and immovable properties in furtherance of the aims of the Society.
  - (k) To collect funds for the proper conduct of the institutions under its care in the manner of donations, contributions, aids, membership fees, etc. as detailed in the Rules and Regulations.
  - (l) To raise funds by arranging benefit performances like Drama, Bharata-Natyam, Music Concerts and such other activities as the Society may think fit and feasible as and when necessary.
  - (m) To do such other things as are incidental or conducive to the attainment of the above objects or any of them.
